### 1. Privacy

#### 1. PRIVACY STATEMENT

- 1.1. Racing Victoria Limited (ACN 096 917 930) (Racing Victoria) is the Principal Racing Authority (PRA) governing thoroughbred racing in Victoria, and carries out the functions of:
  - determining and issuing occupational licences and/or otherwise authorising persons to participate in the Victorian thoroughbred racing industry (Licensed and/or Registered Person);
  - regulating Licensed Persons and/or Registered Persons;
  - administering and promoting racing; and
  - such other functions as may be described in its privacy policy published on its website from time to time, which is available at <https://www.racingvictoria.com.au/privacy-policy> (PrivacyPolicy).
- 1.2. Racing Victoria is collecting your personal information on this form, including your name, contact details, next of kin, employment and credit card/bank details. We may also be collecting personal information about you which may be considered sensitive or protected under applicable laws (such information may include title, criminal record and bankruptcy status) that you may provide in this form or under your relevant licence's ongoing disclosure obligations (if applicable).
- 1.3. Racing Australia Limited (ABN 89 105 994 330 21) (Racing Australia) is the national industry body representing thoroughbred racing in Australia. This application form and your personal information will also be collected by Racing Australia in order to process your application on Racing Victoria's behalf. Where personal information is collected by Racing Australia on behalf of Racing Victoria (as opposed to on its own behalf), it is subject to the Racing Australia and Racing Victoria privacy policies, the latter prevailing in the event of any conflict. - 1.4. The purpose of collecting your personal information is for our legitimate interests, including to:
  - consider and make determinations in relation to your licence application;
  - meet supervisory responsibilities in relation to you as a Licensed and/or Registered Person;
  - promote or protect the integrity of the thoroughbred racing code and ensure compliance with the Rules of Racing;
  - administer and promote racing operations (including your participation in races and the industry); and
  - any other function or activity described in our Privacy Policy.
- 1.5. We are permitted to process your personal information for the above purposes, by relying on one or more lawful grounds: (a) you have explicitly agreed to us processing such information for a specific reason; (b) the processing is necessary to perform the agreement we have with you or to take steps to enter into an agreement with you; (c) the processing is necessary for us to comply with our legal obligations; or (d) the processing is necessary for our legitimate interests, including the administration and promotion of racing operations and ensuring the compliance with the Rules of Racing.
- 1.6. If your personal information is not collected, either on this form or otherwise when requested by Racing Victoria as part of its licensing and supervisory activities, we may not be able to process your application (and therefore refuse to grant your application or renew your licence, as the case may be).
- 1.7. Racing Victoria may also obtain personal (including sensitive) information about you from, or disclose your personal information to, third parties (including, where the EU General Data Protection Regulation (EU GDPR) and/or UK General Data Protection Regulation (UK GDPR) applies, third countries outside of the UK and EU or European Economic Area (EEA)). Where the EU GDPR and/or UK GDPR applies, Racing Victoria implements adequate safeguards recognised by the EU and the UK for transferring such personal information, which may include standard contractual clauses. Racing Victoria may disclose personal information to third parties such as enforcement bodies, government authorities, other racing control bodies (including PRAs and their equivalents in harness and greyhound) in the States and Territories of Australia and overseas, wagering service providers such as bookmakers, totalisators, and betting exchanges, educational or training institutions and to other persons for any of the purposes described above or as otherwise provided by law.
- 1.8. Your personal (including sensitive) information will also be disclosed to:
  - a) Racing Australia in order for them to perform their role under the Australian Rules of Racing; and
  - b) other PRA's (including Racing New South Wales (ABN 86 281 604 417 22), Racing and Wagering Western Australia (ABN 21 347 055 603), Racing SA Limited (ACN 094 475 939 Tasracing Pty Limited (ACN 137 188 286), Thoroughbred Racing NT Incorporated (ABN 15 688 350 211), Canberra Racing Club Incorporated (21 423 896 409) and Racing Queensland Limited (ACN 142 786 874)) for the purpose of administration of thoroughbred racing in Australia.
- 1.9. Unless otherwise advised by you, your image, name and contact details may be published monthly in the Inside Racing magazine and also disclosed to and published by Racing Victoria and its associates (including Victorian Thoroughbred Racing IMB Pty Ltd (including its business Racing.com), Victorian thoroughbred race clubs and Racing Australia) to facilitate your participation in racing, including the publication of race fields and calendars.
- 1.10. We will retain your personal information only for the duration necessary for the purposes identified in this Privacy Statement and in accordance with this Privacy Statement.
- 1.11. We otherwise use, disclose and handle your personal information in accordance with our Privacy Policy. If you are concerned about a possible interference with your privacy, please contact Racing Victoria's Privacy Officer by email at [privacyofficer@racingvictoria.net.au](mailto:privacyofficer@racingvictoria.net.au) or by post addressed to the Privacy Officer at 400 Epsom Road, Flemington, Victoria 3031, Australia. Privacy complaints to Racing Victoria must be made in writing. In cases where the EU GDPR or the UK GDPR applies, you have the right to lodge a complaint with the relevant European Union supervisory authority or the UK Information Commissioner's Office (as applicable).
- 1.12. Where you have consented to our processing of your personal information, you may withdraw such consent at any time (where your local data protection and privacy laws specifically provide you with this right), by contacting us using the contact details provided in section 1.11 above. Please note, however, that in certain circumstances it may be lawful for us continue processing this information even where consent has been withdrawn, if one of the other legal bases described at section 1.5 above is applicable. The Privacy Policy also sets out information regarding your other rights as a data subject (including your right of access, rectification, deletion, restriction and portability your personal information and to not be subject of decisions based solely on the automated processing of your personal information, where appropriate).

## 3. Health Records

- 3.1. In addition to the personal information collected on this form, Racing Victoria will also seek to collect from Victorian-based jockeys, sensitive (health) information including an Annual Medical Report, Computer Cognitive Assessment Tool (CCAT) results and other health and medical information (Health Information) in order to fulfill Racing Victoria's Functions and for the Purpose described above.
- 3.2. If this Health Information is not collected, Racing Victoria will not be able to ensure that persons granted a licence or permit to ride as a Jockey, Apprentice Jockey, Jumps Jockey or Picnic Jockey meet the necessary licence conditions, including that they are physically fit and are able to withstand the rigours associated with riding in races.
- 3.3. Racing Victoria may disclose your Health Information where permitted by law (including under the Workplace Injury Rehabilitation and Compensation Act 2013 (Vic)), to third parties such as service providers and as follows:
- Your Annual Medical Report:
    - o in full, to the Racing Victoria Chief Medical Officer (or their delegate); or
    - o a medical practitioner nominated by Racing Victoria or Racing Victoria's Chief Medical Officer (or their delegate); and
  - Your CCAT results:
    - o to Racing Victoria's Chief Medical Officer (or their delegate) or a Chief Medical Officer of a PRA outside of Victoria.
- 3.4. Racing Victoria's Chief Medical Officer may provide your Health Information to the Chief Medical Officer of a PRA outside of Victoria.
- 3.5. Your Health Information will be treated confidentially at all times and will not be disclosed to any third parties not listed above without your prior consent.
- 3.6. For jockeys based outside Victoria that intend to ride in Victoria, Racing Victoria may request that Health Information be provided by you (or, where you have consented, from the PRA with which you are licensed) to evidence that jockey's fitness to ride. Racing Victoria may also seek from jockeys based outside of Victoria, further Health Information for the purpose of performing Racing Victoria's licensing function in respect to that jockey. All Health Information collected will be handled in accordance with Racing Victoria's Privacy Policy. You may request to gain access to your personal information, including Health Information at any time, by contacting Racing Victoria's Privacy Officer as described above at paragraph 1.11.

## 4. Rules of Racing

- 4.1 I acknowledge that I have read and understood the Rules of Racing of Racing Victoria and of any other Principal Racing Authority in which I ride, and I agree to familiarise and be bound by any amendments to the Rules.
- 4.2 I agree to be subject to, and bound by:
- a. the Rules of Racing of each Principal Racing Authority in which State or Territory I ride, including those Rules as amended or varied by each Principal Racing Authority from time to time; and
  - b. such rules and directions as may from time to time be formed, made or given by the directors for each Principal Racing Authority ("Directors"), the stewards or the Principal Racing Authority ("Stewards") or the officials of any racing club registered by the Principal Racing Authority to conduct thoroughbred racing under the Rules ("Club").
- 4.3 Without limiting any other declaration or acknowledgement made in this application, I declare that:
- a. I understand that as a licensed Jockey, I am not allowed to place a bet and/or have an interest in a bet on thoroughbred racing in Australia or overseas.
  - b. I will not allow any account held with a Wagering Service Provider in my name to be used by any person(s) to place or have an interest in a bet on thoroughbred racing in Australia and/or overseas.
  - c. I will not use an account held with a Wagering Service Provider in another person(s) name to place or have an interest in a bet on thoroughbred racing in Australia and/or overseas.
  - d. I have read and understood the Rules of Racing regarding betting restrictions and offences for jockeys, including AR 115 (1) which provides as follows:

### AR 115 Jockey and apprentice jockey misconduct

(1) A jockey or apprentice jockey must not:

- (a) engage in misconduct;
  - (b) other than from his or her nominator, accept or agree to accept any money, gift, or other consideration in connection with a horse in a race without the consent of the Stewards and his or her nominator;
  - (c) bet, or have any interest in a bet, or facilitate a bet, on any thoroughbred race or contingency relating to thoroughbred racing in any jurisdiction anywhere in the world;
  - (d) be present in the betting ring during a race meeting;
  - (e) bet, or have any interest in a bet, or facilitate a bet, on any thoroughbred race or contingency relating to thoroughbred racing involving a race in which he or she is riding in any jurisdiction anywhere in the world.
- e. I have read AR 115(3) and understand that any jockey who is found guilty of a breach of AR 115 (1)(e) is liable to a period of disqualification of not less than two years (unless special circumstances are found to exist).
- f. I understand that, as a condition or requirement of the grant of my jockey licence renewal, I will be required to sign a "Jockey Declaration Regarding Betting" prior to me being relicensed. Further, I understand that in the Jockey Declaration Regarding Betting, I will be required to declare that I have not had a bet, facilitated a bet, or had an interest in any bet on any thoroughbred race or contingency related to thoroughbred racing in Australia or overseas from the period of 1 May each year (or such other period as advised to me by Racing Victoria in its discretion).
- g. I have read and understood the Rules of Racing regarding the restrictions on jockey involvement in the buying, selling, trading or leasing of thorough bred bloodstock, including AR 117.

## 5. Promotion of Thoroughbred Racing

### 5. PROMOTION OF THOROUGHBRED RACING: IN APPLYING FOR THIS LICENCE OR APPROVAL BEING GRANTED, I:

- 5.1. Likeness and identity: authorise Racing Victoria to use, distribute, display and reproduce my appearance, likeness, name, voice, signature, nickname, reputation, performance or anything else that identifies me (Likeness), including as part of any Recording on any medium now known or hereafter devised and without cost or charge to Racing Victoria including, without limitation, for the promotion and advertising of, or otherwise in connection with, thoroughbred horse racing. If my likeness is proposed to be used prominently and individually, other than as part of the day to day broadcast of racing activities (whether live or non-live) by Racing Victoria or its licensees or Racing Photos official race day photography, then my consent must first be obtained, and I will not unreasonably withhold such consent.
- 5.2. Intellectual Property: agree that Racing Victoria will be the exclusive owner of the results and proceeds of my participation in any racing activity, including, without limitation, any Recording (Material). I hereby assign any present or future right, title and interest in any intellectual property rights, including copyright, I may have in the Material to Racing Victoria. I hereby unconditionally and irrevocably consent to Racing Victoria or its designees doing any or all acts or omissions which may otherwise infringe any moral rights I may have in any Material. The rights and consents granted in this paragraph are given in consideration of Racing Victoria considering this application.
- 5.3. Restrictions on use of image: agree not to allow, authorise or license any person, corporation or entity to use, distribute, display and reproduce my name photograph, likeness, reputation and identity for commercial purposes (including but not limited to licensing, endorsements, advertising, promotions, merchandising, memorabilia, events and marketing) where such utilisation would be prejudicial to the interests or image of thoroughbred racing or which may bring the thoroughbred racing industry into disrepute.
