Late Nomination Fee <i>If a late entry closing time is not specified in the conditions of a race, horses may be entered until 10.00am on the next day (ignoring weekends and public holidays) after the day of the advertised closing time (until 3.00pm Monday for Thursday, Friday and Metropolitan Saturday meetings), or such time as Racing Victoria may direct upon payment of an entry fee of the greater of:</i>	\$200 or 2% of the total prizemoney for the race whichever is the greater amount  The late fee will be refunded if the horse is subsequently eliminated from the race.

Scratching Fee on Veterinary Advice	No Fee <i>- subject to a veterinary certificate supplied not later than 5pm on the second business day next following the day of the running of the race from which the horse was withdrawn. A veterinary clearance will need to be forwarded to Stewards before the horse can compete in another race.</i>	

**Note:** Total acceptance fees for any Group or Listed flat race should not exceed 1.0% of advertised prizemoney (excluding trophies) provided that clubs may at their discretion set total acceptance fees of up to 1.25% on any Group 1 race which has multiple acceptance stage and is a Weight for Age or a 'set weight and penalty' race in which horses older than 3YO can run.
