PANELS COMMENTS

- A post race veterinary examination of Mutajara failed to reveal any significant abnormalities.
- Mutajara has since competed in a hurdle race in South Australia where the horse again recorded a Lost Rider result. SA Stewards have stood Mutajara down from competing in jumps races until a satisfactory trial is completed.
- A post race veterinary examination of Mr. Schiller failed to reveal any abnormalities.
- As this was Mr Schiller's first jumps race and he was hampered by the fallen horse, no action has been taken by the Panel and future jumps performances will be monitored.

- Trainer Symon Wilde advised the Panel he intends to qualify King of the Cross for steeplechase races as he believes he is more suited over these obstacles. The Panel will closely review this trial and assess the horse's performance.
- A Veterinary Certificate must be produced prior to King of the Cross trialling or racing.
- A post race veterinary examination of Vatuvei failed to reveal any abnormalities.

PANELS COMMENTS

- A post race veterinary examination of Nishiazabu failed to reveal any abnormalities.
- No action has been taken against Nishiazabu as the horse was jumping well prior to the 17th obstacle and has a sound jumps record.
- A post race veterinary examination of Undergroundfighter failed to reveal any abnormalities.
- No action has been taken against Undergroundfighter as the horse was jumping well prior to the 17th obstacle and has a sound jumps record.
- A veterinary clearance is required prior to Undergroundfighter trialling or racing again.

- A post race veterinary examination of Riviera Star failed to reveal any abnormalities.
- No action has been taken against Riviera Star as the horse was jumping well prior to being eased out of the race and has a sound jumps record.
- Valediction's jockey Patrick Flood explained that in his opinion something had gone amiss with the horse and this was the reason for the poor performance. A post race veterinary examination failed to reveal any abnormalities.
- No action has been taken against Valediction as the horse was jumping well prior to being eased out of the race and has a sound jumps record.
