PANEL'S COMMENTS

- A post race veterinary examination of Divi Filius failed to reveal any obvious abnormalities.
- No action has been taken against Divi Filius due to the circumstances of the fall.
- A veterinary clearance must be required before Divi Filius is next presented to race.
- A post race veterinary examination of Singersongwriter failed to reveal any obvious abnormalities.

- A post race veterinary examination revealed Big Ben Chimes to be lame in the off fore.
- Trainer Quinton Scott was advised a veterinary certificate of fitness would be required before Big Ben Chimes is next presented to race.
- No action has been taken against Big Ben Chimes as the horse was jumping satisfactorily prior to the last obstacle.
- A post race veterinary examination of Knocka Norris revealed the gelding to be lame in the near fore.
- Trainer E Musgrove was advised a veterinary certificate of fitness would be required before Knocka Norris is next presented to race.
- Eric has since advised the panel Knocka Norris has been retired from racing.

PANEL'S COMMENTS

- A post race veterinary examination of General Sateen failed to reveal any obvious abnormalities
- No action has been taken against General Sateen as it was jumping satisfactorily prior to being eased out of the race.
- A post race veterinary examination of Thorpie failed to reveal any obvious abnormalities.
- No action has been taken against Thorpie as it was jumping satisfactorily prior to being eased out of the race.
- A post race veterinary examination of Mutajara failed to reveal any obvious abnormalities
- The Panel has reviewed all four jumps starts of Mutajara and agreed the horse is not to continue with this jumps preparation and is unable to compete in jumps trials or races again this season.
- Trainer Eric Musgrove has been advised the horse is not longer qualified for the 2015 jumps season.
- In 2016 an application can be made via the Panel to trial Mutajara for re-qualification and this application will be assessed then.
