Any approval pursuant to this application will be valid from the date you receive written approval from RV, until the conclusion of the 2024/25 Racing Season.

Bookmakers must obtain RV's written approval prior to using an ABS and any approval granted is subject to the terms and conditions of a bookmakers' licence, Racing Victoria's Bookmaker Rules (available on the Racing Victoria website), and any other condition as notified by RV.
